## 2019 DUES DATE CHANGE

Aspen Meadows Homeowners;

After careful consideration and after discussing with the homeowners in attendance at the 2018 annual meeting the Association has voted to change its fiscal year from the current 12-month period of January through December to April through March. A fiscal year can be any rolling 12-month period and ideally the time period used generally reflects a point where expenses are minimal. Because major expenses for our Association are incurred between May and February, this change also allows for improved budget reporting at the annual meetings in May. Since our dues are paid annually in advance, the fiscal year change will result in a <a href="mailto:one-time">one-time</a> adjustment in the dues payment; but please understand your 12-month dues total has <a href="mailto:not">not</a> changed.

This one time change applied to dues for the new 2019-20 fiscal year and will encompass a 15 month time period:

- 1. The first year of this switch will result in association members paying 3 months dues in arrears  $(\$18.75 \times 3 = \$56.25 \text{ for Jan, Feb, and Mar 2019}).$
- 2. The standard 12 months in advance will also be billed at this time (usual \$225 for April 2019 to Mar 2020) resulting in a **one-time** total of \$281.25.
- 3. We will delay when dues notices are sent; therefore notices will go out around Feb 15<sup>th,</sup> 2019 with a due date of March 30<sup>th</sup>, 2019. (See schedule below for additional information)
